## RSL Badge and Replacement of Lost RSL Badge

## **RSL** Badge

Badges remain the property of the League, and must be returned if membership is not renewed by 30th April.

To wear a badge when not a member is an imposition of the worst type. Use of the insignia without permission is an offence.

The badge is not complete until current "Year Crown" is affixed, with the exception of Life Subscribers who are issued with a permanent "LS" clip.

## Replacement of Lost RSL Badge

Statutory Declarations may be obtained from State Branch or printed from this site (see next page) which, when completed, should be returned to the State Branch, together with cost of replacement, \$3.85 large badge, \$3.30 small badge (postage cost is additional).

Replacement badges will be issued only in respect of current financial members.

On production of a damaged badge, a new badge will be issued for \$3.85 (plus cost of postage).
